## 6. Old Business

### A. **Underage Sales Violation – Sudden Service #13 – 129 Luyben Hills Road, Kingston Springs, Tennessee. Kingston Springs Beer Permit 3-19-2020-1. (deferred from August 19, 2021 meeting).**

Sgt. Mike Havens, Cheatham County Sheriff's Department and Steve Glidewell, Tri Star Energy/Sudden Service Representative were in attendance. City Attorney Perry swore in Sgt. Havens for his testimony. Sgt. Havens stated that Cheatham County Sheriff's Department conducted a sting across the county on May 21, 2021. Three underage juveniles were attempting to purchase alcohol at establishments that sold alcohol. Attorney Perry asked the age of the juvenile who purchased beer at Sudden Service, and Sgt. Havens reported that the juvenile who successfully purchased alcohol at Sudden Service was 17. He said a hidden camera is used in the sting operation. The teen takes the hidden camera with him when he purchases alcohol. The Sheriff's Department then returns to inform store of underage beer purchase. Mr. Glidewell said that he didn't understand why they waited four hours to inform the store. The store is a Responsible Vendor, and they have video of clerk documenting age as correct age. He said waiting four hours does not allow them to take immediate action and he was not comfortable with the process. Mayor Gross said he can't comment on how the County conducts its beer stings. Sgt. Havens shared a picture of the driver's license with name marked out. It shows the age and red bar noting under 21. It was also pointed out that the license was vertical rather than horizontal which is another indication of someone under age. Commissioner Clark asked Mr. Glidewell about the company's policy. He stated that employees go through a 3-day training and every day must sign the Good Vendor policy. Commissioner Hargis, Mayor Gross and Vice-Mayor Remick all said they were in favor of a \$500 fine. City Attorney Perry said that the Commission had set a precedent of a \$500 fine for first offense. Since Sudden Service was a Responsible Vendor, the fine could be no higher than \$1,000. Motion to fine Sudden Service \$500 for underage beer sales made by Commissioner Hargis, with a second by Vice-Mayor Remick. Roll call vote was held with Commissioner Clark voting yes, Mayor Gross voting yes, Commissioner Hargis voting yes, and Vice-Mayor Remick voting yes. Commissioner Eatherly was absent. Motion passed.

On December 9<sup>th</sup>, 2021, The Cheatham County Sheriff's Office conducted an underage beer buy operation in Cheatham County. This operation was conducted using eighteen (18) to twenty (20) year old confidential informants. On this date forty-eight (48) retail establishments in Cheatham County were visited and the confidential informants attempted to purchase an alcoholic beverage. As a result of this operation five (5) establishments allowed our confidential informants to successful complete a purchase for alcoholic beverages. Those establishments are as follows:

PIERCE, TONY

On December 9th, 2021, between the hours of 1700 and 2000, The Cheatham County Sheriff's Office conducted an underage beer buy operation. As a part of this operation, pursuant to Tennessee Code Annotated 39-15-413, all retail establishments in Cheatham County that sell alcoholic beverages were visited and an underage (aged 18-20 year old) confidential informant entered each of the establishments and attempted to purchase an alcoholic beverage. Each of these attempts were recorded by video recording device and the identity of the listed clerks was compared with the video to establish identification.

As a result of this operation, 4 stores were found to be in non-compliance with Tennessee Code Annotated 57-5-301, Sale of Alcohol to Underage Persons.

The Following Stores were found to be non-compliant by allowing an underage person to complete a purchase of an alcoholic beverage.
