7. New Business

A. <u>Underage Sales Violation – Thorntons LLC – 120 Luyben Hills Road, Kingston Springs, Tennessee. Kingston Springs Beer Permit 6-2-2019-1.</u>

City Manager Lawless gave background on the incident. On December 9, 2021 the Cheatham County Sheriff's Office conducted an underage beer buy operation across Cheatham County. During this operation a clerk at the Kingston Springs Thorntons located at 120 Luyben Hills Road allowed purchase of an alcoholic beverage to an underage patron. The establishment was notified of the violation by the Cheatham County Sheriff's Office and the clerk was issued a citation to appear in General Sessions Court on February 9, 2022. This is Thorntons second violation. First was in August, 2021. Deputy Anthony Pierce was sworn in by City Attorney Noe and spoke on behalf of the Cheatham County Sherriff's Office. The Thorntons' representative said the employee who sold the beer is no longer employed. Thorntons has increased training for verifying IDs, and all employees have been recertified. The Sheriff's Department gave the manager pointers to pass along to her team so that it doesn't happen again. Commissioner Stohler recused himself. City Attorney Noe said that the Board could impose the maximum fine or permit suspension, since Thorntons was not a responsible vendor. Commissioner Clark asked if there was a time frame when they were supposed to become a responsible vendor. Mayor Gross said that the Responsible Vendor Program is not a requirement, but it is something they can seek if they want to. There are benefits for a company to be a Responsible Vendor. Vice-Mayor Remick motioned to fine Thorntons the maximum penalty of \$1500.00 in lieu of suspension, with a second by Commissioner Hargis. Motion passed unanimously.
